

Position Overview

We are looking for a motivated Refurb IT Technician to establish a role, which is crucial for our growth strategy, focusing on engaging with customers, building rapport and establishing robust business relationships. The successful candidate will play a key role in our mission to provide exceptional product and (e-)service solutions to businesses and domestic customers, helping them to efficiently meet their operational e-waste reprocessing needs. The Refurb IT Technician is expected to undertake, in joint co-ordination with the e-Waste Manager and Refurb IT Manager, the separation of any recyclable items, ensuring that any waste electronic and electrical equipment (WEEE) for refurbishment is safely segregated. The Refurb IT Technician responsibilities include inspecting, testing, and repairing the segregated tech such as computers, laptops, printers, smart phones, etc, and to undertake 'off-site' and 'on-site' data sanitisation services. Many companies require their e- Refurb IT Technician candidates to have some sort of professional qualification, and earning one is often a good first step in pursuing this career. Candidates with a professional qualification are encouraged to apply for this position as it is desirable. However, iTech-Co does not have a strict major requirement for this, as extensive experience will be respected. The job is mainly worked from the process facility but may sometimes involve assisting collections throughout the South Wales area (may be extended to other areas in due course) to undertake 'on-site' data sanitisation services. You may need to wear protective clothing, and your working environment may be dirty and physically demanding, as the Refurb IT Technician often engages in physically demanding work such as handling WEEE. So, the job would be suitable for someone who is physically fit and has stamina, someone who is reliable, can communicate technically and clearly, has strong people skills and very knowledgeable in IT.

Refurb IT Technician Job Responsibilities

♣ Adhere to schedules, plans and policies, to deliver safe and sound procedures and customer service standards.



- Accomplish staff objectives by undertaking tasks given by the Refurb IT Manager.
- Communicate job concerns to management and input job contributions.
- Lata sanitisation is the process of permanently deleting or destroying data from a storage device to make it irretrievable. This is done by overwriting all existing data with random patterns using software in line with the British Government HMG Infosec Level 5 Enhanced Standard for data destruction. Failing to destroy data securely raises the risk of unauthorised access, leading to identity theft and fraud. At iTech-Co, we understand the requirements and obligations concerning data security, which is why we only use one of the best in industry methods and tools to carry out our data sanitisation services. That's why iTech-Co offers an 'OFF-SITE' and 'ON-SITE' data sanitisation services, which guarantees 100% of our customers data is destroyed. iTech-Co's specialist software allows us to process any requirements of data sanitisation from a single hard drive up to 16 hard drives (and other storage media types) connected to one device in one wipe enabling us to automatically erase up to 16 disks at once in parallel. We can work in situ to carry out multiple simultaneous wipes to the same level of erasure. Our data sanitisation service is designed to mitigate risk to keep our customers business compliant and secure. It is the responsibility of the Refurb IT Technician, to offer a full audit trail of each storage media sanitised, which is supported with a certificate of data destruction with itemised reporting so our customers a have a digital record in pdf format of all items erased off/on site. In the UK, the HMG Infosec Level 5 Enhanced standard, set by the National Cyber Security Centre (NCSC), provides stringent guidelines for this process. By adhering to HMG Infosec Level 5 Enhanced, organisations can ensure the secure disposal of sensitive data, mitigate risks of data breaches, and avoid potential penalties. A crucial element of HMG Infosec Level 5 Enhanced is the need for physical security precautions to safeguard the storage media throughout the sanitisation procedure. This includes secure storage and the presence of authorised personnel throughout the process. Therefore, at iTech-Co, all data-bearing media is kept in a designated secure location within our process facility and the Refurb IT Technician must be a DBS-Enhanced Vetted Member of Staff.



- Undertake the packaging and labelling of segregated e-waste to be resold and keep a record of repairs and fixes for future reference.
- ♣ Quickly identify the source of an IT issue, testing solutions, and evaluating data to choose the best course of action.
- ♣ Fixing and maintaining computers, laptops, servers, and other technology equipment such as smart phones, etc.
- Configure internal computer and IT hardware/software.
- ♣ Process certificates of destruction for data sanitisation, tech re-use and end-of-life WEEE and see to environmental agency documentation.
- Working closely with clients and colleagues, including other engineers, and management.
- Ensuring tools remain in good working condition by cleaning them after each job.
- ♣ Liaise with staff, partners, IT parts suppliers and customers.
- Ensure to maintain a clean work area and keep it organised.
- Check the condition of equipment & machinery regularly.
- Ensure appropriate safety signage is in use.
- ♣ Respond to faults or hazards reported escalate where necessary.
- Identify marketing opportunities by understanding consumer requirements, analysing market trends to identify new opportunities and competitive threats.
- ♣ Improve product marketability and profitability by identifying and capitalizing on market opportunities.



- ♣ Promote the importance of e-waste management and educate the community about the negative effects of improper e-waste handling.
